Why do you want to serve on the Carlisle Borough Council?

As a native of Carlisle who has seen the community go through many transformations over the past several decades, I have been excited to see the progress made by the Carlisle Borough Council over the past several years towards fostering a more inclusive and resilient community. From the Anti-Discrimination Ordinance of 2016 and the establishment of the Human Relations Commission, to the more recent Truth and Reconciliation Commission to address racial inequity and the newly approved Climate Action Plan, the Council is enacting positive change for all of its citizens. When we founded Cumberland Valley Rising in 2016, one of our stated goals was to "defend and promote the core American values of diversity, inclusivity, freedom from bigotry and oppression and access to education." Unfortunately, in many communities even in south central Pennsylvania, the defense and promotion of these values remains an uphill battle, so it is wonderful to see a forward-thinking local government positioned at the forefront of this effort. I think it is important that our local government be representative of our local community, and I would like to see greater diversity than currently exists on the Council.

What prior experience can you bring to Borough Council that will benefit the Carlisle community?

Professionally, I have spent the past 13 years working in the non-profit sector in Carlisle, first at the Bosler Memorial Library and now at the Carlisle Family YMCA, and as such have a strong knowledge of the needs in our community that non-profit agencies struggle to address daily with limited resources. My work has provided me with a wide network of contacts not only in the non-profit community but also the local business sector, and I enjoy working creatively and collaboratively to tackle tough problems. I am a graduate of the 2020 class of Leadership Cumberland, which is a program that focuses not just on the development of individual leadership skills but also in fostering the importance of volunteer leadership in the community.

Additionally, as a co-founder and former Vice-President of Cumberland Valley Rising, I have experience in harnessing the collective energy of large groups of people to bring about positive change. With the late Robin Scaer of the YWCA Carlisle, I organized an anti-racism rally on the Carlisle Square in August 2017 in the wake of the devastating events in Charlottesville. Speakers

from the U.S. Army War College, Dickinson College, local congregations and state and local government spoke to a crown of hundreds who sought lasting social change. As the Voting and Elections Chair of Cumberland Valley Rising, I encouraged a number of individuals to run for local offices throughout the greater Carlisle area including for school board director, council member and township supervisor, inspector of elections and even the state legislature, and though not all of those candidacies were successful, they nonetheless served by example to inspire others around them to take a greater interest in local elections and local issues.

What objectives and projects do you envision Carlisle pursuing in the next five years?

Affordable rental housing has been and remains a serious problem within the borough, and with rising rents over the past few years seems to be an even more urgent issue to address. Wages have not kept up with increased housing costs, and creative solutions are needed in order to address homelessness and housing shortages for struggling families.

I applaud the efforts made over the past decade to make Carlisle a more walkable city that is bicycle-friendly, but I hear constantly from residents who do not feel safe cycling on some streets, and would encourage more work on this issue. Additionally, I would like to see greater opportunities for public transit if we are to address long-term traffic and parking issues and make car-free living in our downtown truly possible. Relatedly, I would like to see an investment in the infrastructure needed to sustain widespread adoption of electric cars to help make Carlisle a "hub for vehicle electrification" as outlined in the recently adopted Climate Action Plan.

I also believe that the newly formed Truth and Reconciliation Commission will help to identify a number of concrete steps that the Council can take to address towards correcting racial disparities in local housing, employment, criminal justice and more, and that this work should be held as a priority to be urgently addressed.
