

ORDINANCE NO. 2250

AN ORDINANCE OF THE BOROUGH OF CARLISLE, CUMBERLAND COUNTY, PENNSYLVANIA, AUTHORIZING THE BOARD OF SCHOOL DIRECTORS OF THE CARLISLE AREA SCHOOL DISTRICT TO ASSUME HIRING AND OVERSIGHT OF SCHOOL CROSSING GUARDS.

WHEREAS, the Borough of Carlisle is located within the Carlisle Area School District (the "School District"); and

WHEREAS, the Borough Code, Act 2014-37, as amended, 8 Pa.C.S. § 1127, authorizes the School District to assume the hiring and oversight of school crossing guards upon enactment of an ordinance by Borough Council after adoption of a resolution by the Board of Directors of the School District; and

WHEREAS, the Board of Directors of the School District adopted a Resolution on June 16, 2016 requesting from Borough Council the authority to assume the hiring and oversight of school crossing guards.

NOW THEREFORE, IT IS HEREBY ENACTED AND ORDAINED by the Borough Council of the Borough of Carlisle, Cumberland County, Pennsylvania, as follows:

SECTION 1: The Board of School Directors of the Carlisle Area School District shall assume the hiring and oversight of school crossing guards.

SECTION 2: The Borough of Carlisle Police Department shall provide such training and assistance to the crossing guards while on duty, as deemed necessary by the Police Chief of the Borough of Carlisle, from time to time.

SECTION 3: The training to be provided to the crossing guards shall consist of the following:

- a. Basic traffic laws of the community.
- b. School zone signage and pavement markings.
- c. Proper use and purpose of traffic signs and signals.
- d. Methods of signaling drivers.
- e. Crossing procedures.
- f. Site-specific traffic factors and potential traffic hazards.
- g. Proper attire and behavior to remain safe and to project a positive public image.
- h. Proper use of safety equipment.
- i. Emergency procedures and procedures involving suspicious persons or activities appearing detrimental to children.

SECTION 4: School crossing guards shall be authorized in the management of traffic and pedestrians in and around those areas identified by the Borough of Carlisle Police Department and the Superintendent of the School District or the Superintendent's designee.

SECTION 5: The School District shall assume all costs of compensation, including fixing compensation, if any, of the school crossing guards.

SECTION 6: The Board of School Directors of the School District shall notify Borough Council of the individuals hired to serve as school crossing guards and request the necessary training or assistance be provided as outlined by this Ordinance.

SECTION 7: All ordinances or resolutions or parts thereof inconsistent herewith are hereby repealed.

SECTION 8: This Ordinance shall become effective immediately.
