ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE PROVIDING FOR A TEMPORARY PARKING BAN BETWEEN CERTAIN HOURS ON CERTAIN DAYS BETWEEN THE MONTHS OF APRIL THROUGH OCTOBER 2016, ON CERTAIN STREETS IN THE VICINITY OF THE CARLISLE FAIRGROUNDS.

WHEREAS, the Borough Council has undertaken a thorough review of the parking and associated problems caused by the large crowds attending the scheduled events at the Carlisle Fairgrounds; and

WHEREAS, after completing its review, Borough Council believes it to be in the best interest of the health, welfare, and safety of the residents living in the area adjacent to the Fairgrounds to take appropriate action to limit the vehicular traffic congestion in the area; and

WHEREAS, the Mayor concurs that such action should be taken to regulate temporary parking; and

WHEREAS. Section 244-3 [Temporary and emergency regulations] of Article I [General Provisions] of Chapter 244 [Vehicles and Traffic] of the Code of the Borough of Carlisle provides, in Subsection C thereof, for the imposition of temporary parking bans, by resolution or ordinance, with posting of temporary “No Parking” signs in the affected areas 24 hours in advance of the period of such bans, and provides for procedures, costs, and penalties in connection with violations of such bans.

NOW, THEREFORE, IT IS HEREBY ENACTED AND ORDAINED by the Borough Council of the Borough of Carlisle, Cumberland County, Pennsylvania, as follows:

SECTION 1: Pursuant to Subsection C of Section 244-3 [Temporary and emergency regulations of Article I [General Provisions] of Chapter 244 [Vehicles and Traffic] of the Code of the Borough of Carlisle, no person shall park a vehicle, or allow a vehicle to remain parked, upon any of the streets set forth hereafter, between the hours of 8:00 A.M. and 8:00 P.M. on the days of Wednesday, April 20, 2016, through and including Saturday, April 23, 2016, and Wednesday, September 28, 2016, through and including Saturday, October 1, 2016, and between the hours of 8:00 A.M. and 4:00 P.M. on Sunday, April 24, 2016 and Sunday, October 2, 2016:

SECTION 2: Pursuant to Subsection C of Section 244-3 [Temporary and emergency regulations] of Article I [General Provisions] of Chapter 244 [Vehicles and Traffic] of the Code of the Borough of Carlisle, no person shall park a vehicle, or allow a vehicle to remain parked, upon any of the streets set forth hereafter, between the hours of 8:00 A.M. and 5:00 P.M. on the days of Thursday, April 21, 2016, through and including Saturday, April 23, 2016, and Thursday, September 29, 2016, through and including Saturday, October 1, 2016.

SECTION 3: Pursuant to Subsection C of Section 244-3 [Temporary and emergency regulations] of Article I [General Provisions] of Chapter 244 [Vehicles and Traffic] of the Code of the Borough of Carlisle, no person shall park a vehicle, or allow a vehicle to remain parked, upon any of the streets set forth hereafter, between the hours of 8:00 A.M. and 8:00 P.M. on the following days: Saturday, April 23, 2016; the days of Friday, May 20, 2016, through and including Saturday, May 21, 2016; the days of Friday, June 3, 2016 through and including Saturday, June 4, 2016; the days of Friday, June 17, 2016 through and including Saturday, June 18, 2016; the days of Friday, July 15, 2016 through and including Saturday, July 16, 2016; the days of Friday, August 5, 2016, through and including Saturday, August 6, 2016; the days of Friday, August 26, 2016, through and including Saturday, August 27, 2016, and the days of Friday, September 30, 2016 through and including Saturday, October 1, 2016. Further, no person shall park a vehicle, or allow a vehicle to remain parked, upon the streets set forth hereafter, between the hours of 8:00 A.M. and 4:00 P.M. on the days of Sunday April 24, 2016, Sunday, May 22, 2016, Sunday, June 5, 2016, Sunday, June 19, 2016, Sunday, July 17, 2016, Sunday, August 7, 2016, Sunday, August 28, 2016 and Sunday, October 2, 2016.

SECTION 4: Procedures, costs and penalties applicable to violations of the temporary parking ban contained herein shall be as set forth in Section 244-3 (C) of Article I of Chapter 244 of the Code of the Borough of Carlisle.
